The Bainbridge Township Board of Trustees met in Regular session at the Bainbridge Town Hall on December 16, 2013. Those present were trustees Mr. Christopher Horn, Mr. Jeffrey S. ROUTINE BUSINESS

Employment of Public Employee

Mr. Horn made a motion to hire Mrs. Kathleen Hurley as a temporary part time assistant to the Service Director while the Administrative Assistant is on maternity leave, effective immediately for training at a rate of \$14.00 per hour, per the recommendation of the Service Director.
