

**BAINBRIDGE TOWNSHIP PARK BOARD MINUTES**  
**AUGUST 17, 2011**

Mr. Sfiligoj, Chairman called the meeting to order at 7:00 P.M. at Settlers Park.

**MINUTES**

Mr. Whaley made a motion to approve the meeting minutes dated July 20, 2011 as written.

Mr. Preuss seconded the motion that passed unanimously.

**PROPERTY SUPERINTENDENT'S REPORT**

Monthly Report

Mr. Mitchell stated that there is a new look to the monthly report and it now shows the year-to-date expenses and revenues.

Military Flags at Heritage Park

Mr. Mitchell reported that the military flags are needing to be replaced frequently because of wind damage. Mr. Sfiligoj suggested seeking donations for the flag replacements and giving the used flags to older Bainbridge Township veterans according to the military branch they served. Mr. Mitchell said that he has been giving the used flags to the Aurora VFW for proper disposal.

River Road Park Playground

Mr. Mitchell stated that a catch basin was recently installed which will eliminate a lot of the water from washing out the new playground mulch. He also stated that he had the help of six kids from the county who helped with the topsoil and the hand shoveling. He added that he would like to have the pavilion painted this year.

KCE

Mr. Mitchell stated that the agreement with KCE is continuing to go well.

Landscaping

Mr. Mitchell discussed the landscaping with the board and stated that JFD's contract has been extended for another year.

### Encroachments - Centerville Mills Park

Mr. Mitchell explained that there have been some encroachments on the Centerville Mills Park property from neighboring properties and he is seeking advice from the county prosecutor's office. He presented the board with photos of the encroachments.

### Aurora Co-Op Preschool - Nature Playground (Centerville Mills Park)

Mr. Mitchell reported that he has met with Ms. Mary Ann Aardema of the Aurora Co-Op Preschool regarding the Nature Playground she would like to install at Monkey Island and that it is still going forward. He said when the design is completed, it will be presented to the Park Board before any work is done.

### Chemical Bathrooms

Mr. Mitchell reported that the chemical bathrooms have been ordered but a local contractor will be needed for the installation, a permit from the county is required and they will be ready to be delivered in six to eight weeks.

### Frisbee Golf at Centerville Mills Park

Mr. Mitchell said the Frisbee Golf is going well except there have been some complaints from the dog walkers.

### Settlers Park

Mr. Mitchell stated that the bollards around the parking lot need to be replaced before the chip and seal is done and the drainage under the road has been fixed.

### Centerville Mills Park Water System

Mr. Mitchell explained the water system at Centerville Mills Park and that it is regulated by the EPA and must be tested everyday except for weekends.

Since there was no further business, Mr. Preuss made a motion to adjourn the meeting. Mr. Whaley seconded the motion that passed unanimously.

The meeting was adjourned at 8:35 P.M.
