### **PUBLIC COMMENTS:**

- Heather White, parent of a new 10-12 year old boys fall baseball league brought up an issue regarding the rental procedure, insurance, and rates at the Bainbridge Parks.
  - Two letters were presented regarding better rates in Aurora, no fall baseball through KCE, confusing web site rental instructions etc.
