NEW BUSINESS

Temporary Signs

Mr. Lateulere explained that in November of 2019 the Zoning Commission updated the signage portion of the zoning resolution and prior to that there were no provisions for temporary signs but sandwich board signs are now permitted. See below.

"A business use having an exterior store front or entrance may have a maximum of one (1) temporary sandwich board or A-frame sign. The sign shall be located within three (3) feet measured from the exterior store front or entrance to the interior side of the sign so as not to impede pedestrian traffic. The sign shall have a maximum height of three (3) feet and a maximum width of two (2) feet. The sign shall not be illuminated and shall be displayed only during the hours of operation of the affected business."

The Zoning Commission met with business owners Ms. Kimberly Gibson of the Hungry Bee and Mr. Ron Silverman of Bainbridge Antiques for a discussion on temporary signs. Mr. Andrew Shibley representing the Bainbridge Commons and Ms. Traci Piazza were also present via Zoom.

Mr. Silverman explained his hardships of not being able to have a temporary sign at the street because his business is not visible from the street.

Ms. Gibson said that she is here on behalf of other businesses in the township as well and explained her hardship being in the restaurant business during this pandemic and how important temporary signs are for her business because her demographics are older and not on Facebook etc. so her sandwich board is significant for her sales. She said she really relies on her sandwich board and she can't have it 3' away from her building because no one will see it from the road.

Mr. Andrew Shibley explained that he is with Shibley Properties, the owner of Bainbridge Commons and they support the sandwich board signage which will help new tenants or tenants with promotions throughout this difficult period of COVID.

The Zoning Commission held a discussion with the business owners on temporary signs and discussed possibly a temporary moratorium on temporary signs during the COVID pandemic or the initiation of a zoning amendment to amend the zoning resolution. No decision has been made at this time.

OLD BUSINESS

Proposed Zoning Amendment Chapter 119 - Architectural Review Board

The Zoning Commission reviewed the latest draft of the proposed Architectural Review Board amendment, dated November 30, 2020, and made some modifications to it. It was agreed to continue the review of this proposed amendment at the next meeting.
