## General Zoning Discussion

The Zoning Commission held a general discussion regarding large lot zoning, density and ground water and was in agreement to invite Mr. Michael Joyce, Zoning Inspector to attend the next meeting.

### **Pervious Materials**

The Zoning Commission discussed the use of pervious materials for parking lots and driveways which is a technique used to reduce storm water run-off. Mr. Sheehy stated his concerns with the product regarding installation, maintenance and enforcement. The members were in agreement to remove this item from the agenda.

The Zoning Commission acknowledged Mr. David Weiss and his 15 years of service on the Bainbridge Township Zoning Commission. The members were in agreement to recommend to the township trustees that a thank you letter be sent to Mr. Weiss for his service to Bainbridge Township.
