# Chagrin River Watershed Partners

The zoning commission discussed the letter from the Chagrin River Watershed Partners, dated July 10, 2007 regarding Funding for Member Comprehensive/Land Use Plan Updates and the township's current land use plan.

# Former Geauga Lake Park Property

The zoning commission discussed the property at the former Geauga Lake Park site. The members asked the students in attendance what they would like to see on that site and the male students responded that they would like an indoor/outdoor water park and the female students would like a Cocker Park type of shopping center.

# Chagrin River Balanced Growth Pilot Project

The zoning commission discussed the proposal by the Chagrin River Watershed Partners. They were in agreement that given the potential for future changes at the former Geauga Lake Park property and the Route 422 interchange, a study would be most viable for the E. Washington Street and Route 306 (Chillicothe Road) corridor.
