# Proposed Mixed Use Planned Unit Development Zoning Amendment

The Zoning Commission discussed the quote from Ms. Jennifer Syx of inSITE Advisory Group for the purpose of developing the proposed Mixed-Use Planning District (MUP) zoning amendment.

The members held a telephone conversation with Ms. Syx to discuss the project overview and deliverables. She will be extrapolating all of the mixed use zoning language that is currently in the proposed Comprehensive Zoning Resolution Rewrite that was prepared by Kendig Keast Collaborative and creating a new mixed use district. Items that need clarification are the development mixture; block sizes; purpose statement and housing types.

## Motion

Ms. Byrne made a motion to recommend hiring Ms. Jennifer Syx of inSITE Advisory Group for the purpose of preparing the legislation for the new Mixed Use Planned Unit Development District (MUP), based on the submitted proposal, at a fee not to exceed \$3,750.00.
