Minutes of Zoning Commission

The zoning commission members acknowledged the re-appointment of Mr. Steve Hunder; the appointment of Mr. Charles Nichols as a regular member and the appointment of Mr. Howard Miller as an alternate member.

MINUTES

Mr. Sheehy made a motion to approve the minutes of the February 23, 2010 meeting as written.

Mr. Watson seconded the motion that passed unanimously.

OLD BUSINESS

Surveyor and Professional Assistance

Mr. Sheehy reported that the Board of Trustees agreed to provide funding for a surveyor and professional assistance. The surveyor is needed for the proposed re-zoning of parcels within the township from Residential to Active or Passive Park Districts and the professional assistance is needed for the proposed zoning amendment regarding signage. He said the trustees were in favor of obtaining bids or quotes for the above mentioned projects.

The zoning commission discussed the hiring of a zoning planner or legal consultant to critique the proposed signage amendment and to strengthen other areas of the zoning code.

Also discussed were changeable copy signs and temporary text signs.

Mr. Sheehy will create the scope of work for the surveyors and Mr. Wrench will contact area surveyors and planners/legal consultants for quotes.

Mr. Wrench explained the status of the proposed windmill at Kenston High School.

Riparian Setbacks

Mr. Wrench reported that Ms. Amy Holtshouse-Brennan of the Chagrin River Watershed Partners will be attending a Zoning Commission meeting, in the near future, to discuss the status of the township's Riparian Setback regulations.
