## **Zoning Inspector Report**

Ms. Karen Endres, Zoning Inspector reported on the Discount Tire Store that is proposed for Aurora Road, the dance studio that is going to occupy the former Dress Barn store, the Cedar Fair property and noted that an inquiry was recently made regarding a proposed marijuana grow site in the township.

# <u>Cleveland State University Student Project – Former Geauga Lake Park Property</u>

Ms. Jennifer Syx reported that the CSU students will be presenting their version of the Geauga Lake master plan, which is their capstone project, on May 1<sup>st</sup>.

## Permeable Pavers

The Zoning Commission discussed the use of permeable pavers with regards to lot coverage calculations and noted that the current zoning resolution does not address permeable pavers.

#### Agriculture

Mr. Lateulere reported that recently introduced H.B. No. 175 will amend sections 303.21 and 519.21 and to enact section 901.60 of the Revised Code to allow an owner of a residential property to keep, harbor, breed, or maintain small livestock on the property, and to prohibit zoning authorities from regulating certain agricultural activities conducted on residential property for noncommercial purposes.
