Riparian Setback Map

Mr. Weiss reported that the Riparian Setback Map was revised by the Geauga County Planning Commission based on information received from the Chagrin River Watershed Partners, Inc. and it was recommended by the planning commission to amend the map through a zoning amendment. The zoning commission members were in agreement to initiate an amendment to the Bainbridge Township Riparian Setback Map.

Proposed Amendment to Riparian Setback Map

That an amendment to the Bainbridge Township Riparian Setback Map of one page, marked Exhibit A attached hereto and incorporated herein, be hereby initiated by the Bainbridge Township Zoning Commission on this 26th day of May, 2005.
