## Proposed Zoning Amendment Z-2019-1

The Zoning Commission reviewed subject application and met with Mr. Dale Markowitz, who represents the applicant.

The Zoning Commission accepted a proposed amendment submitted by 7207 Chagrin Industrial, LLC which proposes to rezone PPN# 02-419836 (7207 Chagrin Road) consisting of 2.85 acres and 7209 Chagrin Hemlock, LLC which proposes to rezone PPN# 02-376800 (7209 Chagrin Road) consisting of 1.49 acres from Professional Office District (P-O) to Limited

Industrial Restricted District (LIR). The applicants are also requesting that Section 155.02(a) be amended to add a permitted use, where a zoning certificate is required, for exercise and fitness studios, martial arts facilities, yoga studios and similar disciplines and related facilities.

Ms. Walkush made a motion to accept this proposed amendment and to enumerate it as Amendment Z-2019-1, and to set the public hearing for June 25, 2019 at 7:15 P.M. at the Bainbridge Town Hall, 17826 Chillicothe Road, Bainbridge Township, Ohio and to request the Bainbridge Township Board of Trustees to issue a purchase order for the necessary legal advertisement.
