The Bainbridge Township Board of Trustees met in regular session at the Bainbridge Town Hall on December 17, 2007. Those present were trustees Mr. Christopher Horn, Mr. Jeffrey S. Markley and Ms. Linda W. White and Fiscal Officer Susan R. Angelino. Mr. Horn presided and called the meeting to order at 6:30 P.M.

### PUBLIC COMMENTS/VISITING PUBLIC

### ENGLISH DRIVE HOUSE EXPLOSION

A hidden pocket of natural gas, inadvertently opened by drilling may have caused an explosion at 17975 English Drive.

The trustees met with Fire Chief Brian Phan, Ohio Valley Energy and residents from English, Kingswood and Scotland Drive.

Chief Phan explained that natural gas had bubbled into the home's well water, filled up the basement and somehow ignited. Dozens of households have been evacuated and E. Ohio Dominion Gas and O.D.N.R. are investigating. If residents have a problem they may contact the Bainbridge Fire Department at 543-9873 or Ohio Valley Energy at 330-799-2268.

Concerns from residents:

- Who will continue to monitor water in the future and how can we be sure it is safe? - O.D.N.R. (Ohio Department of Natural Resources) will be responsible party.
- If problem is extensive, will all residents be notified? Yes, immediately - O.D.N.R. will inform residents.
- Was Ohio Valley Energy aware that they had hit a gas pocket? - Yes.
- Do residents need to keep monitoring their water? Yes. - If you see a change in color, etc. call Fire Department.
- 5. Need to notify residents when officials are on their property checking wells.
- 6. Right now you are bringing in water. What if my house is never habitable? What should I do?
- 7. Are there long term health issues to be concerned about?
- 8. Will all wells in area affected be tested? Yes.

### PUBLIC HEARING - PROPOSED ZONING AMENDMENT Z-2007-1

Mr. Horn recessed the trustees' regular meeting and opened the public hearing for proposed zoning amendment Z-2007-1 at 7:15 P.M.

Mr. Horn noted that the legal notice for this public hearing was duly published in the News Herald on December 7, 2007. This amendment proposes to amend the Definition of Structure.

This amendment was initiated by the zoning commission on October 25, 2007; and the Geauga County Planning Commission on November 13, 2007 voted to recommend approval of Z-2007-1, with comments as listed. The Bainbridge Township Zoning Commission held a public hearing for proposed amendment on November 29, 2007 and subsequently recommended approval of the amendment.
