Mr. Lynch moved that the Bainbridge Township Board of Trustees to into executive session to discuss the employment of a public employee.

Ms. White seconded the motion. Vote: Mr. Lynch, aye; Mr. Markley, aye; Ms. White, aye.

The trustees recessed their regular meeting at 6:21 P.M. in order to go into executive session to discuss employment of a public employee.

The trustees returned from executive session after discussing the employment of a public employee and reconvened their meeting at 7:00 P.M.

MR. MATT DOLAN, STATE REPRESENTATIVE

Mr. Lynch welcomed everyone to the meeting to discuss the gas/oil well drilling issue. The particular well of interest is now referred to as Dolan #1 by the Ohio Department of Natural Resources, and has not yet been issued a permit.

Mr. Dolan was introduced and stated that he was speaking on behalf of the Dolan family. The company's request to drill is completely legal and the company planned to go above and beyond the required safety precautions. However, after much consideration and concerns from the residents near the intended drilling site, the company has withdrawn their request to drill and there will not be any drilling on the 422 Company Ltd. Property.

Mr. Lynch asked the residents to continue their interest and use that passion to help other neighborhoods fight their battles.

Senator Tim Grendell thanked Mr. Dolan and the entire Dolan family for their consideration of the local residents and taking the residents concerns seriously. This was the first time in five years that Sen. Grendell has seen this happen. He encouraged the residents to ask people from outside of Northeast Ohio to contact their elected representatives and express their concerns regarding HB 278.

TRUSTEES CORNER

Park Board

The Trustees were in general agreement to accept the resignation of Vince Meier from the Park Board.

MAT Cleaning

The Trustees were in general agreement to have Mr. Shane Wrench review the contract with the new cleaning company personnel.

Aurora Co-Op
