PUBLIC COMMENT

Historical Society

Mr. Karl Kuckelheim presented a list of historical homes located within Bainbridge Township including century homes as well as those with historical value. This list was requested by Ms. White. Township Administrator Mr. Joyce was asked to make sure Ms. White received a copy of this list.

TRUSTEES CORNER

Letter to Kenston Community Education

Mr. Lynch drafted a letter to KCE from the Board of Trustees asking the KCE Board if they would be interested in assuming maintenance and upkeep of the Bainbridge School in order to run their proposed programs. The trustees were in general agreement to have the letter sent to Kenston Community Education.

Liquor Permit

Mr. Lynch stated that Police Chief Jimison does not object to a request for a liquor permit for South Franklin Circle. This is for resident use within Judson and not for use by the general public.

Mr. Lynch made a motion to waive any objection to a liquor permit for South Franklin Circle per the recommendation of the Police Chief.

Mr. Markley seconded the motion that passed unanimously.

Hawksmoor Way

Mr. Lynch asked Mr. Markley for an update on the Hawksmoor Mr. Markley clarified that the Homeowners are Way project. willing to place a conservation easement on part of the stream located on property owned by the Hawksmoor Homeowners We then need to contact Western Reserve Land Association. Conservancy since they are adjacent land owners. We would still have to pay some amount but it will be reduced by an easement from the land owned by the Homeowners Association. Mr. Markley will now move forward on this project with the Geauga County Engineer's office. The work is anticipated to be done during the driest part of the year, presumably late July to early August. One issue is the movement of dirt, but the poor soil can be moved to township property on the north side of Bainbridge Road.

Kenston Lakes Dam

Mr. Lynch stated that the members of the Board of Trustees each received a copy of an operating agreement between Bainbridge Township and the Chagrin River Watershed Partners. This was reviewed by the Prosecutor's office and everything looked acceptable.

Mr. Markley walked the site with the Geauga County Commissioners to prepare for the public hearing to be held March 24, 2009 regarding the repairs to the area and road over the Kenston Lakes Dam.

Nichols Property

Mr. Markley suggested that the Board of Trustees send a formal letter to Mr. Don Nichols in response to his letter offering the Township the first right of refusal on the purchase of his property on Chillicothe Road.
