NEW POLICE STATION

Exterior Material Color Approval

Public Hearing - Proposed Zoning Amendment Z-2003-1

Mr. Hesse noted that the legal notice for this public hearing was duly published in the News Herald on May 9, 2003. This amendment proposes to rezone parcels 02-412700, 02412800, 02-419931 and 02-421000 from R-3A Residential Three Acre to CB Convenience Business.

This amendment was initiated by The Winbury Group on January 30, 2003; and the Geauga County Planning Commission on February 11, 2003 voted to recommend denial of Z-2003-1, with comments as listed. The Bainbridge Township Zoning Commission held a public hearing for proposed amendment on February 27, 2003, March 27, 2003 and April 24, 2003 and subsequently recommended denial of the amendment.

BID FOR TANGLEWOOD TRAIL ROAD PROJECT - PHASE 2

Mr. Desiderio made a motion to award the bid for the Reconstruction of a Portion of Tanglewood Trail, TR484, Phase II, Contract #RC-TR484-03 to Northeast Ohio Trenching Service, Inc. for \$311,983.40, per the recommendation of the Geauga County Engineer's Office. (P.O. 175)

Mr. Hesse seconded the motion that passed unanimously.

ZONING

ABATEMENT OF EXCESSIVE VEGETATION

Mr. Hesse moved and Mr. Desiderio seconded the motion that passed unanimously.

Based upon the report and evidence received from Zoning Inspector Frank McIntyre, it is determined that a nuisance exists at parcel #02-419590, Bainbridge Township as recorded in Volume 0929, Page 829 of the Geauga County Records of Deeds, in that there exists excessively tall grass and vegetation.

Mr. Robert Miller and Tanglewood Associates, owners of the aforementioned real property, are hereby ordered to remove such excess grass and vegetation within seven (7) days from receipt of this notice. Should said owners fail to remove the excess grass and vegetation within seven days, Bainbridge Township shall cause the vegetation to be removed and costs for such removal shall be forwarded to the Geauga County Auditor for entry upon the tax duplicate pursuant to O.R.C. 505.87.

The trustees authorized the clerk to notify Mr. Robert Miller and Tanglewood Associates and all lien holders of the above.
