Mr. Horn seconded the motion that passed unanimously.

ROAD DEPARTMENT

Bids for the Pavement Recycling and Asphalt Resurfacing of Various Roads in Bainbridge Township

At this time we'll consider awarding the contract on the project entitled the pavement recycling and asphalt resurfacing of various roads in Bainbridge Township. Shelly Co. is the lowest bidder, however, the Township has experienced a series of problems with the performance of Shelly Co. and Thomas Asphalt Paving Co., its predecessor in interest, on a previous project, entitled the reconstruction of Tanglewood Trail, TR 484 and a portion of Northbrook Trail, TR 127 in Bainbridge Township, Contract No. RC-TR 484.02.

According to the notice to proceed for that earlier project, dated June 24, 2002, Thomas was required to complete all work on this project by November 2, 2002. Thomas had numerous problems meeting the work schedule, and did not timely complete the project. When Shelly purchased Thomas on or about June 1, 2003, and undertook performance of the contract, there was no change in the management of the work schedule, and Shelly failed to complete the project in a timely fashion. As of November, 2003, Shelly still had not completed work under the contract. Over several months the township and county engineer notified Shelly of problems with its performance.

Further, a resident Jeff Imka's June, 2003 claim for property damages caused by Shelly has not been handled professionally or appropriately by Shelly.

These problems with Shelly's performance and other related issues are detailed in a series of letters, including the letter from the Township's counsel John Tremsyn to Thomas, dated November 7, 2003; Shelly's letter in response, dated November 11, 2003; Shelly's letter to the Township, dated February 20, 2004; Donald Bagley, Esq.'s letter to Shelly, dated February 26, 2004; Mr. Tremsyn's letter to Shelly, dated March 4, 2004; the County Engineer's letter to Shelly, dated April 19, 2004; and the Engineer's letters of May 6, 2004 and May 14, 2004 to the Trustees. These letters have been reviewed and considered by the Trustees, and are attached to the minutes of this meeting.

This board is required to award the contract to the lowest and best bidder. The bid award is based on, among other things, the ability of the bidder to execute the contract properly, the Township's evaluation of the bidder's ability to service the public, the Township's knowledge of experience with the bidder's past performance, and the Township's needs and requirements.

The Trustees have reviewed the bid packet of the second lowest bidder, Ronyak Bros. Paving, Inc. and find it is complete and meets the specs for the job. Ronyak's bid was \$2,653.80 or 0.32% higher than the apparent low bid. This Board has knowledge of Ronyak's good past performance in completing projects, and, based upon the Township's knowledge and experience, Ronyak can meet the Township's needs. The township cannot afford to expend the time and money nor to endure the inconvenience that would potentially arise from a repeat of the problems encountered during Thomas and Shelly's performance on the previous contract.

Based upon this information, Mr. Desiderio made a motion that the Township not consider Shelly's bid as the best bid and instead to award the above referenced contract to Ronyak Bros. for \$821,826.30.

Mr. Horn seconded the motion that passed unanimously.
