The Bainbridge Township Board of Trustees met in regular session at the Bainbridge Town Hall on September 7, 2009. Those present were trustees Mr. Matthew J.D. Lynch, Mr. Jeffrey S. Markley and Ms. Linda W. White and Fiscal Officer Mrs. Cherianne H. Measures. Mr. Lynch presided and called the meeting to order at 7:00 P.M.

PUBLIC COMMENT

Julius Ferencie of Geauga Lake Road is concerned about the number of fire and rescue calls in the area of the shopping centers near the former Geauga Lake Park and he is concerned that the fire chief is only part time and wondered if we should not have a full time chief.

Thomas Keck questioned what the Sunshine Law is regarding emails. Mr. Lynch clarified that emails constitute public records and is not effected by the Sunshine Laws. Any emails regarding Township business whether business or personal email accounts constitute public records. Public records requests can be made through the Town Hall on the official form.

TRUSTEES CORNER

Ms. White informed the public of an email received from Chagrin River Watershed Partners and a stream restoration project done with the Holden Arboretum and an open house that they will be having.

Mr. Markley has reviewed the landscaping contracts and is concerned that there is no fertilization included. Ms. White stated that Mr. Mitchell is having that quoted separately.

Mrs. Measures reminded the board that the township administrator, Michael Joyce, would like to attend the Leadership Geauga class and would like the township to cover the cost of the class for \$875.00. Ms. White is concerned about the time commitment that this class would require on top of his current duties, including Board of Zoning Appeals meeting on Thursday evenings. Mr. Markley echoed Ms. White's feeling on the time commitment and Mr. Joyce's current duties as both Zoning Inspector and Township Administrator.

There was a general disagreement regarding this training and therefore it was not approved.

Mr. Lynch explained that he has emailed our investment advisor and there is just over \$2,000,000 that will be matured before year end and asked the Fiscal Officer if her concerned have been satisfied. Mrs. Measures stated that her only concern is whether the township is required to maintain a certain amount of cash available or if all of our monies can be tied up in investments.

Policy Updates: Gift Amounts

This board feels that the taxpayers monies should not be used in this way. The employees that work with the employee experiencing the hardship could collect monies for flowers or fruit baskets or whatever the employees deem necessary, but it will no longer be paid for by the township using taxpayers dollars. The board was also in general agreement not to provide retirement parties in the future.

The board was in general agreement to continue to send fruit baskets to the volunteer board members.

The board was in general agreement to continue this discussion when the Township Administrator is available.
