Proposed Zoning Amendment

The Zoning Commission accepted a proposed amendment submitted by Frank and Doris Lanza which proposes to amend Section 141.02 of the Bainbridge Township Zoning Resolution by adding Subsection 141.02(d), to add Child Day-care Centers as a conditional use in the Professional Office District, and adding Subsection 117.13(c) to add specific regulations for Child Day-care Centers as a conditional use in any district.

Mr. Weiss made a motion to accept this proposed amendment and to enumerate it as Proposed Amendment Z-2002-7 and to set the public hearing for November 26, 2002 at 8:00 P.M. at the Bainbridge Town Hall, 17826 Chillicothe Road, Bainbridge Township, Ohio and to request that the Bainbridge Township Board of Trustees issue a purchase order for necessary legal advertising and the services of a court reporter.
