208 Plan

A discussion was held regarding the current 208 Service Plan map for the township dated July 2015, the MOU dated June 13, 1998 between Bainbridge Township Board of Trustees and the Geauga County Board of Commissioners regarding sanitary service areas and a proposed map dated January 19, 2023 received from Mr. Nick Gorris, Geauga County Sanitary Engineer. It was noted that the Board of Trustees approved an amended 208 Service Plan map dated June 27, 2022 and this map was transmitted to the county. No action was taken on this matter by the Board of County Commissioners. Chairman Lateulere indicated that he would contact Dr. Michael Bates, Township Trustee Chair and Zoning Department liaison regarding this matter.
